We specialise in relaxed yet elegant functions within our beautiful garden and marquee.

Our venue is ideally suited for gatherings of between 25 and 120 guests, offering a welcoming and picturesque setting to celebrate.

Functions are welcome in our garden, with fees commencing from \$500-\$1000, depending on guest numbers for a roped-off section of the garden.

\$2000 for exclusive use of the gardens (marquee included).

Sit down marquee event setup charge is an additional \$1500. This includes: tables and chairs, lighting, table linen, cutlery, crockery and glassware.

In the event of wet weather, the marquee is available free of charge for guests who have booked an outdoor event (additional setup charge for seated event).

Final numbers and payment

Payment terms are as follows:

10% deposit and signed agreement must be received to secure your booking. Full payment of remaining balance is required 30 days prior to the event.

Confirmation of numbers is required 30 days prior to the event.

Payment can be made in cash, direct deposit or credit card. Credit card payments attract a surcharge.

Security Bond

Client responsibilities
